## **ORDINANCE NO. 10-2022**

## A FY 2021-2022 BUDGET ORDINANCE AMENDMENT NO. 1 FOR CLEVELAND COUNTY WATER

WHEREAS, in accordance with applicable provisions of the North Carolina Budget and Fiscal Control Act, Cleveland County Water finds it advisable and necessary to revise and amend its annual budget for FY 2021-2022: and,

WHEREAS, the General Manager (Budget Officer) has recommended certain amendments to the budget which the governing body finds acceptable; and,

WHEREAS, the Cleveland County Water Board of Commissioners now desires to act on the recommended budget amendments and approve the same for implementation and compliance with the Fiscal Control Act;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF CLEVELAND COUNTY WATER, LAWNDALE, NORTH CAROLINA:

Section 1: Cleveland County Water's FY 2021-2022 Budget is hereby amended as follows to provide for Budget Amendment No. 1 for the year:

- (A) The Board of Commissioners, in order to provide funding for the purchase of vehicles and equipment, must appropriate sufficient revenues and expenditures to make funding available.
