

## **ADVERTISEMENT FOR BID PROPOSALS**

### **Replace Water Lines Damaged by Hurricane Helene Plan Set #1 – 7 Creek Crossings Plan Set #2 – Rollingbrook Court**

Sealed bids for this project will be accepted until 10:00 AM on February 13th, 2026. At that time the bids will be publicly opened and read aloud. The bid opening will be held at the Cleveland County Water Office at 715 Polkville Rd.

The proposed work consists of replacing water lines damaged by Hurricane Helene. Plan set #1 includes seven creek crossings consisting of 553 LF of 4" Ductile Iron waterline, 1,527 LF of 6" Ductile Iron waterline, 332 LF of 12" Ductile Iron waterline and all other associated appurtenances. Plan set #2 consist of one CMP culvert crossing with 162 LF of 4" Ductile Iron waterline and all other associated appurtenances required for successful project completion, as described and shown on Plans and Special Provisions prepared by TGS Engineers.
